HISTORY IN THE MAKING--OUR FIRST IMPACT GRANT

In the summer issue of Giving Matters, we announced the Foundation was making a major step forward in terms of grantmaking—a move into community leadership. The first step was to award an “impact” grant in one of our fields-of-interest. Our Board of Trustees chose the Education field-of-interest, and then our Program Committee went to work identifying potential recipients.

After a thorough search, we have selected the recipient of our \$50,000 Impact grant: **Running Start for Careers!**



Here’s why:

Research has shown that large-scale social change comes from cross-sector coordination. “Substantially greater progress could be made in alleviating many of our most serious and complex social problems if nonprofits, governments, businesses, and the public were brought together around a common agenda to create collective impact.”¹

Running Start for Careers is a collaborative effort that partners with out-of-state funders including the Kellogg and Daniels Foundations; works in conjunction with local businesses and industries like construction and healthcare; and receives support from entities like APS and CNM to marry educational opportunity with economic impact.



Education is the foundation of self-sufficiency and stability. Running Start for Careers is an education program tackling the student achievement crisis by introducing high school juniors and seniors to career options through dual-credit classes. Exposure to industries like construction, film, healthcare, hotel management, tourism, and finance opens students’ eyes to career options they may never have considered. “This program catches students before they drop out. There is a dramatic effect in investing in these kids today, both on an educational level and on an economic level,” stated Program Committee Chair, Jennifer Thomas.



Running Start for Careers was the brain child of Mayor Richard Berry when he served in the state legislature. Since its implementation in 2012, the program has grown to include 150 Albuquerque Public School students and is expanding into other communities in the state, such as Farmington and Santa Fe. “This program is scalable to any community across the United States. It is nimble enough to take advantage of industry opportunities that may relocate to any given city,” noted Kevin Yearout, Foundation Trustee.



In our roles as Board Chair and CEO, we are proud to see the Foundation add Impact Grantmaking to its other areas of grantmaking--competitive and donor-advised. We are proud to collaborate with our donors and nonprofit organizations to do good for our community and, now with this extraordinary program and its many partners, in building a vibrant community.

GREAT GRANT - *Rio Grande Community Farm*

A Foundation grant allowed for the hiring of a part-time Education Coordinator to oversee development of education programs. The program includes school tours, workshops, curriculum-based teacher training, and the first "Farm Summer Camp." All programs offer experiential environmental education about life on a working organic farm and helps to open students' eyes to the wonders and possibilities of the natural world and their own potential. Beyond the wonderment and exhilaration of hiking alongside a traditional acequia, harvesting garden vegetables, and creating arts and crafts from natural materials, guidance and instruction by on-site farmers and environmental and community educators provides focus on the environment, health and nutrition, and business education. Through age-specific activities, children learn about organic and sustainable farming, ecology, natural history, and energy systems and cycles.

WELLS FARGO

Though the name has changed, the philanthropic support from Wells Fargo Bank has been unwavering. Dating back to our beginning, Wells Fargo has supported the Foundation's operational costs every year—even establishing a permanent Administrative Endowment Fund in 1994. "Corporate administrative support allows the Foundation to maximize the effect of other donations which go directly to its grant program," stated then-President of the bank Larry Willard, who served on the Foundation's Board of Trustees and Investment Committee. A few years later, the bank established an Impact Endowment Fund—unrestricted dollars that are awarded annually to address the community's most pressing needs. The same year, a fund would be established for the benefit of the New Mexico Symphony Orchestra. In 1997, recognizing the importance of developing the next generation of givers, Wells Fargo played an important role in supporting a new program called the Future Fund. According to Foundation staff members, the young group may never have survived without the financial support of Wells Fargo, which made grant dollars available the first several years. This motivated Future Fund members to grow an endowment so they could award grants with their own funds. (Now in its 16th year, the Future Fund endowment has grown to \$430,000!)
